## **COOPERATION AGREEMENT**

City of Chisinau May 16, 1994

In compliance with the Protocol of the Meeting of Delegations of Moldova and Pridnestrovie from April 23, 1994, and the Statement of the leaders of Moldova and Pridnestrovie, guided by the interests of the population of Moldova and Pridnestrovie and the documents of the Convention on International Civil Aviation opened for signing at Chicago on December 7, 1944 in order to ensure flight safety of aircraft in the region, the State Administration of Civil Aviation of Moldova represented by Director General Lishan Pavel Terentyevich, on the one hand, and Office of Aviation of Pridnestrovie in the face of Chief Kaydalov Leonid Alekseevich, on the other hand, have entered into this Agreement as follows:

## 1. SUBJECT OF THE AGREEMENT

Coordination of activities, establishment and development of mutually beneficial cooperation in the field of aviation services and operations in order to better meet consumers' demands.

## 2. LINES OF COOPERATION

State Administration of Civil Aviation of the Republic of Moldova represents interests of the Civil Aviation of Pridnestrovie in international organizations of CA; in its turn, Office of Aviation of Pridnestrovie ensures fulfillment of the requirements of the documents regulating activity of the CA.

The Parties undertake:

- **2.1.** To exchange information on all lines of activity of the CA.
- **2.2.** To exchange analytical and research materials within the subject of Agreement on the results of the work of subordinate structures, and civil aviation development programs.
- **2.3.** To take measures to ensure efficient and safe use of airfields and airspace in the interests of Partners to Agreement.
  - **2.4.** On the proposal and in the interests of a Partner to Agreement, to provide:
  - the work of subordinate rescue and other flight support services;
- functioning of channels of communication and information in-flow. To meet this, a single system of the previous channels of aviation and meteorological communication and air communication links agencies are to be restored.
  - **2.5.** Through joint efforts to ensure:
- the conclusion of agreements between the Office of Aviation of Pridnestrovie and relevant governmental body of the Ministry of Defense of Russia on granting airfield in Tiraspol the status of joint airdrome;
- the use of airspace and flight safety of aircraft on and from the territory of Pridnestrovie, including aircraft owned by the Office of Aviation and its subordinate enterprises and organizations;

- flights of aircraft through transit corridors Chisinau Turbo Odessa, Tiraspol Petrovka Kivok, Tiraspol Chisinau, Tiraspol Shiryaevo and opening of international airline Tiraspol Kamenka Vinnitsa;
- organization within a unified system of air traffic control of an independent Air Traffic Control (ATC) from Tiraspol airfield by the Office of Aviation to the east of the Gyska village shot point Kivok line, in the altitude range from 0 to 1500 m, and above 1500 m upon consultation with ATC airport in Chisinau, developing single ATC-related documents and arranging anti-hail works;
- survey of airfields Tiraspol and Kamenka to estimate their capacity for carrying out regular passenger air travel, as well as preparation of the required documents on certification of the given airfields;
- carrying out of necessary measures to execute certification of aviation enterprises and organizations, aircraft, experts, equipment of the Pridnestrovien CA.
- **2.6.** To facilitate absolute fulfillment of agreements, including previously concluded ones between the State Air Company "Air Moldova", on the one hand, and the Office of Aviation, aviation companies and organizations of Pridnestrovie, on the other hand.

To undertake joint procurement and placing into operation of equipment, technologies and programs that increase flight safety, aviation security and sustainability in communication links functioning.

To assist in the establishment and development of mutually advantageous cooperation by subordinate aviation structures.

In emergency situations and upon the Partner's request, to provide airfields, landing areas and air terminals for passengers and aircraft of the Partner to Agreement. At the same time, to ensure unimpeded delivery of passengers, baggage, cargo, mail and aircraft to their destination.

At Partner's suggestion, to carry out other kind of work in the framework of this Agreement.

To carry out targeted work on the creation of a unified system of the Civil Aviation functioning.

Agreement shall enter into force on the date on which it is signed by the Parties and shall be terminated by mutual agreement.
