PROTOCOL DECISION

on the Arrangements Reached

for the Draft of the Joint Action Plan by Authorized Structures of the Sides in the Area of Environmental Protection and Sustainable Use of Natural Resources in 2013-2014

July 17, 2013 Vienna

During the meeting of the "Permanent Conference on Political Issues in the Framework of Negotiations on the Pridnestrovian Settlement", Political Representatives of the Republic of Moldova and Pridnestrovie exchanged views on the Draft of the Joint Action Plan by Authorized Structures of the Sides in the Area of Environmental Protection and Sustainable Use of Natural Resources in 2013-2014, being discussed by the Expert (Working) Groups of the Republic of Moldova and Pridnestrovie on Ecology and Agriculture (hereinafter referred to as "the Plan").

Taking into consideration particular importance of the Plan in the field of environmental protection and protection of the ecosystem of the river Dniester,

Recognizing demand of both sides for effective and coordinated measures in order to reduce the risks in the field of ecology,

Political representatives of the parties have agreed as follows:

To instruct Heads of the Expert (Working) Groups on Ecology and Agriculture:

to hold within 10 days a meeting of the Expert (Working) Groups in order to sign the Plan with regard to the agreements set forth in this Protocol;

to take the necessary measures to implement events set out in the Plan as quickly as possible;

to consider possibility of making additional provisions in the Plan with regard to joint arrangements on approval of projects in Dniester dredging and channel cleaning.

Recommendations to the Expert (Working) Groups on the terminology to be used in the Plan shall be attached to this Protocol Decision.

Recommendations to the Expert (Working) Groups on the Terminology to Be Used in the Plan by Authorized Structures of the Sides in the Area of Environmental Protection and Sustainable Use of Natural Resources in 2013-2014

- To designate the phrase "authorized structures of both sides in the relevant area" as the name of bodies responsible for implementation of the provisions of the Plan subject to joining columns which contain them;
- To replace the words "legislative and regulatory" to "regulatory and procedural" in paragraph 1 of the Plan before its final approval and signing, to exclude the words in brackets in paragraph 7 of the Plan, to exclude the word "regulation" in paragraphs 8 and 10.
